Lifetime Warranty

Miramac, Inc. makes the following limited warranty with respect to roofing and siding manufactured by Miramac, Inc. Miramac Inc warrants its painted steel roofing to not perforate when used in accordance with the requirements and limitations provided herein.

TERMS: In order for this limited lifetime warranty to apply, the end-user must Install or erect the panels in accordance with industries recommended procedure. Properly protect the panels from exposure to weather or moisture prior to installation. Not alter, remove or change locations of roofing and siding panels, flashings, accessories or fasteners once installed. Maintain the panel by cleaning annually with mild detergent and clean water. Notify Miramac, Inc. in writing, via registered mail, within (30) days after failure occurred. Adequately identify the material involved in the failure including the date of purchase, date of installation and the invoice number must be provided by the buyer. Do not take corrective action until Miramac, Inc. has examined the product and approved the corrective action to be taken. Must register warranty with Miramac, Inc. within 30 days of purchase. Miramac shall have no obligations under this warranty unless and until Miramac receives payment in full for the materials furnished.

LIMITATIONS: The limited lifetime warranty does not apply to or cover: Defects or failure by Acts of God, falling objects, external forces, explosions, riots, civil commotions, acts of war, vandalism, radiation, harmful gases or fumes, chemicals or foreign substances in the air or atmosphere, i.e abnormal quantities of sand or dirt particles. Damage caused by handling, cleaning, shipping, transporting, processing, or condensation caused by improper packaging or storage of the material. Exposure to saltwater, marine atmosphere, acid rain or chemicals. Damage caused by improper cleaning or failing to remove debris from the surfaces of the sheets or panels. Regardless of roof or pitch, installation must provide for proper drainage so as not to hold water. Presence of damp insulation, condensation or other corrosive materials in contact with or close proximity to the panel.

Perforation from fasteners or subsequent damage due to a reaction between the panel and fastener. Exposure to animal by products or waste. Panels used outside of the continental United States excluding Alaska, Hawaii and Canada. Accessories, flashing, fasteners and other components. Roofing having a pitch of less than 2:12. Chalking in excess of industry standards. Failure of the metal substrate. Failures resulting from edge corrosion.

CLAIMS: Miramac, Inc. shall not in any event be liable for any special, indirect, or consequential damages and is not responsible for labor related to the replacement or repair of failed panels. If after Miramac, Inc. has inspected the product and determined a failure, the following compensation scale will be used. Years after date of shipment zero to ten years, Miramac, Inc.'s. Share would be 100 percent. Over eleven years through fifteen years, Miramac, Inc.'s. share would be 75 percent. Over sixteen years through twenty years, Miramac, Inc.'s. share would be 50 percent. Over twenty-one years through twenty-five years, Miramac, Inc.'s share would be 25 percent. Over twenty-six years, Miramac Inc.'s share would be 10 percent. The End-user will be responsible for payment if any is required before Miramac Inc. will supply replacement material. Material will be from Miramac Inc.'s current list price of equivalent product and shall provide materials from current inventory and color selections F.O.B. Spokane, Washington. Miramac Inc. reserves the right to modify or terminate the warranty at any time. This limited lifetime warranty shall

extend exclusively to the original purchaser of the material. This limited lifetime warranty shall be governed by the laws and regulations of the State of Washington and in the event of litigation arising out of this agreement the venue shall be Spokane County, Washington. Reasonable attorney's fees and costs shall be awarded to the prevailing party pertaining to the enforcement or interpretation of this limited lifetime warranty.

EXCLUSIVE LIMITED LIFETIME WARRANTY: Miramac, Inc. makes no warranty, either expressed or implied, beyond the face hereof, including, without limitation, warranty of fitness for a particular use and merchantability, and shall have no other liability with respect thereto. Except as provided herein Miramac, Inc. shall not be liable for any losses, damages or expense, whether direct, incidental or consequential, caused by or resulting from the use of defective or non-conforming products.
